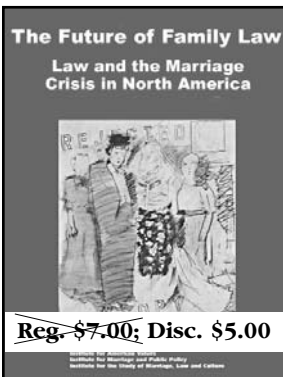

Over 100 family and legal scholars come together to acknowledge some key propositions about marriage and family law in the United States. They draw attention to an increasingly disturbing trend: As scholars in other disciplines come to shed increasing light on the importance of marriage as a key social institution, family law as a discipline is moving in the opposite direction, embracing family diversity as the moral ideal which should undergird family law.
